### APPLICATION INFORMATION:

- Any application not having all of the required information (please refer to your MPC application packet) by 5:00 P.M. on the filing date will not be accepted by MPC staff.
- **A pre-application meeting is required (prior to the submittal of) all Site Plan and Planned Unit Development (PUD) applications.** It is recommended that you schedule the pre-application meeting with an MPC Planner **at least three weeks in advance of the filing deadline** in order to assess the accuracy and completeness of your request and required submittal documents. Failure to do so may result in a significant delay in scheduling your application for MPC Board consideration.
- The application filing fee is **non-refundable** unless the application is withdrawn within the same week it was filed. All withdrawals must be submitted in writing (letter or email) to the MPC staff.

### ZONING AND PUD INFORMATION:

- All **Rezoning and PUD cases are recommendations only from the MPC Board** and are not final until the appropriate governing body has taken action (City Council for City cases, Parish Commission for parish cases). Please be advised that this process typically takes from 45 to 90 days.

### APPEALS:

- All MPC Decisions are subject to appeal to the appropriate governing body.
- For cases appealed to the Parish Commission, a \$250.00 filing fee is **only required** if appealed by the applicant. There is no fee for appeals by an aggrieved party in the Parish.
- For cases appealed to the City, a \$250.00 filing fee is required regardless of who makes an appeal.
- The appeal period starts the day after the decision is made by the MPC Board and runs for 10 calendar days.
