Mr. Sepulvado:

The owner/developer of the facility at the referenced location is requesting a temporary Certificate of Occupancy due to the reason described below.

The detention pond, landscaping, and sprinkler system for the development was damaged late this past week by private communication providers while installing their facilities to the building. The extent of the damage was extensive enough that a final Certificate of Occupancy could not be issued. The developer is working the private utility companies to confirm the depth of their buried facilities, to lower their facilities as necessary, to repair the sprinkler system, to repair the landscaping, and to correct the surface damage to the detention pond.

The corrective earthwork cannot be performed effectively until the pond site dries some.

All corrective work will be completed by August 31, 2024.

I will make observations of the corrective work for conformity with the design plans.
