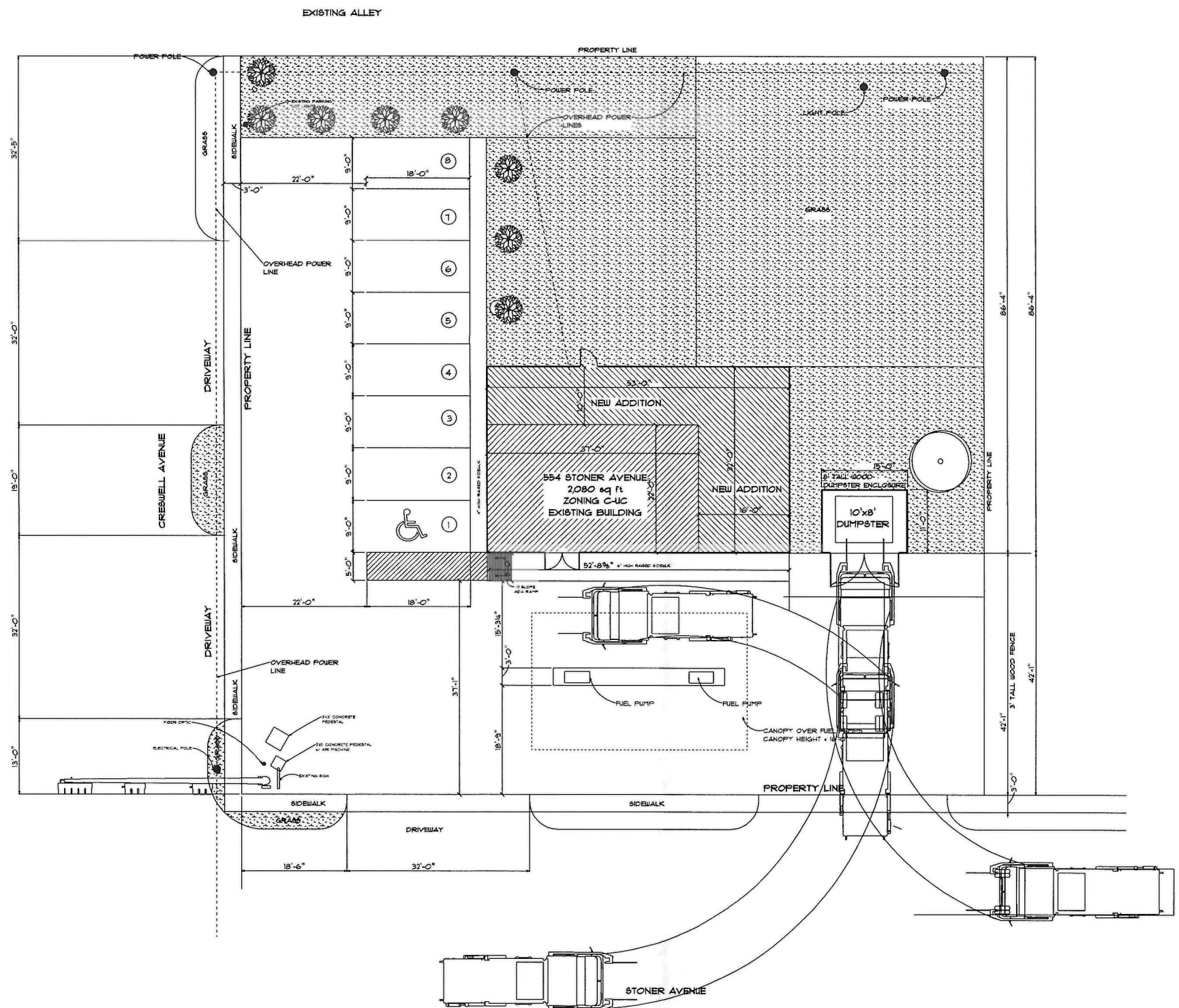

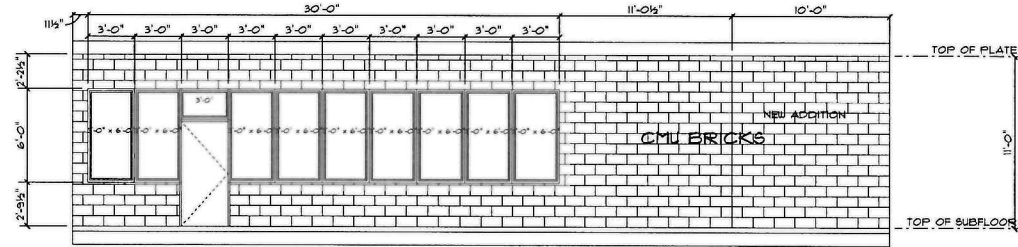

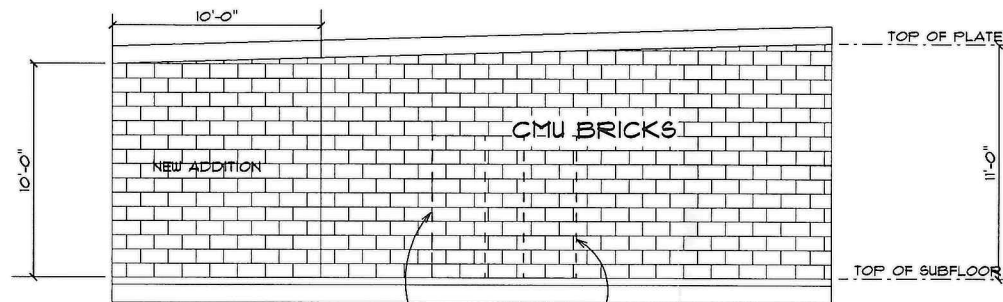


**SOUTH ELEVATION**

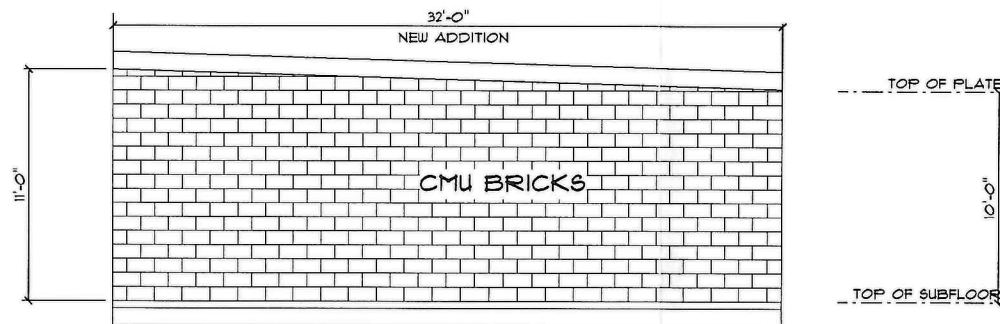
