Mr. Clarke introduced James Djamba as the Neighborhood and Community Planner to the MPC. Mr. Djamba recently graduated with his Master's Degree in Community Planner from Auburn University. Mr. Clarke noted that a second Neighborhood and Community Planner will be hired soon. The planners would provide extensive research on all areas that are affecting Shreveport-Caddo Parish.

# OTHER MATTERS TO BE REVIEWED BY THE COMMISSION Director's Report:

Mr. Clarke thanked Mr. Remedies for his comments regarding the UDC Billboard Amendments.

Reginald Jordan was introduced as the new Zoning Administrator.

Due to conflicts with other government agency schedules, the next MPC Public Hearing will be on July 10th instead of July 3rd.

Mr. Clarke shared information to the Board regarding I-49 and 3132 progress. A 150 million dollar budget was approved by the House for I-49 inner city connection construction; it is awaiting the Senate vote. There has yet to be an update on 3132. Kent Rogers will be in attendance of the July 10th meeting to provide further updates.

The consultants for Choice Neighborhoods will return to provide a report on the project. Mr. Clarke invited the Board members to comment on the initiative.

Mr. Clarke stated that SporTran will have autonomous buses in the near future. He shared with the Board that Shreveport has one of the best transportation systems in the State; information he learned at the American Planning Association Chapter Conference.

### **CHAIR/BOARD MEMBER'S COMMENTS**

Mr. Andrews, who served as acting Chair for the hearing, welcomed the new staff. He commented on how well the staff members are working and would like a tour of the MPC office to really understand what duties each employee holds.
