Mr. Clarke informed the Board that the current charge is \$25 per structure which is the lowest review fee in the area. Chairman Jackson requested that the Board be kept apprised of the situation.

Mr. Andrews asked Mr. Clarke to remind the Board about Ethics Training which is due no later than December 31st.

Mr. Clarke informed the Board to expect amendments to the telecommunication ordinances in January which will be presented and ready for review at that time.
