OLD BUSINESS

Mr. Bailey, Community Planning & Design Manager, informed the Board that the City of Shreveport small wireless ordinance became effective May 2, 2018 that allows for small wireless facilities in the City public rights of way. Applications will be submitted to the MPC, then to wireless consultants who will then submit the applications to the City of Shreveport Engineering Department who has the right of final approval of the application. The City of Shreveport UDC Article 22 amendment that was recommended for approval by the Board in February is currently being revised to better blend with the City ordinances with regard to telecommunications. The revised amendments will be presented to the Board at the June 6th meeting and copies of the amendments will be provided as soon as available.

Mr. Sweeney, Executive Director, informed the Board that the Town Hall meeting of April 11th at LSUS-University Theater went well with the development and design community with approximately 103 in attendance. Theron Jackson, Chair, Nancy Cooper, Vice-Chair, and Winzer Andrews, Secretary, were in attendance and participated in the panel; Alan Young, Lea Desmarteau, Bessie Smith and Ronnie Remedies were in attendance in the audience as well which required the posting of the meeting as a quorum. Mr. Sweeney informed the Board that the MPC staff was in the process of developing a detailed

report to address all the issues that were brought forth at the April Town Hall. In addition, the second Town Hall meeting has been scheduled for Thursday, May 17, 2018 at 1 p.m. at the LSUS-University Theater where the report will be presented and more information provided with regard to the site plan review process and procedures.

Mr. Sweeney reminded the Board that the Tier 2.1 Financial Disclosure Statement is due May 15th to the State Board of Ethics. Copies were provided to the Board.

NEW BUSINESS

Mr. Sweeney, Executive Director, informed the Board that the MPC Personnel Policy has been revised and a draft version has been sent to Rick John, MPC Attorney, for legal review. A draft version will then be sent to the Rules and Procedures Committee (Curtis Joseph, Chair) for comment and further revision at a scheduled meeting later in May. Once the committee is satisfied with the new policy, the full Board will be given a copy for consideration.

Mr. Sweeney informed the Board that Alan Clarke, Zoning Administrator, received the Volunteer of the Year award from the Louisiana Chapter of the American Planning Association during the recent National Planning Conference held in New Orleans April 20th through April 24th.

Mr. Sweeney also reminded the Board that Friday, May 4, 2018 at 12 noon a Master Plan Committee meeting will be held in the MPC large conference room with lunch provided by the City of Shreveport at 11:45 a.m.

CHAIR/BOARD MEMBER'S COMMENTS

Lea Desmarteau provided a power point presentation on the National APA Conference which she attended that highlighted the need for planning for equity, public/community engagement, and whether zoning can truly be kept simple or not. It was noted that only per diem, registration and parking fees were borne by the taxpayer for the Board members in attendance at the National APA conference.

Ronnie Remedies questioned Theron Jackson, Chair, if the personnel matter that had been brought to the Board's attention had been addressed yet. Mr. Jackson responded that as far as the Board is permitted, it is being addressed.
