### OTHER BUSINESS

Selection of Nominating Committee for 2018 Officers
Chair Alan Berry selected Mrs. Cynthia Pearson, Mr. Marshall Ferrell and Dr. Stewart to be on the Nominating Committee and to report their recommendations to the Board at the December 20, 2017 hearing.

**Master Plan Implementation Report** Caddo Parish has adopted the UDC in 99.5% same form as the City of Shreveport with an effective date of December 1, 2017. The MPC staff recommended the same UDC fee schedule to the Parish that is presently in the City of Shreveport UDC, but the Long Range Committee for the Parish chose a different fee schedule which may be heard at the Parish Commissioners' meeting as soon as the next meeting on November 20, 2017. Currently, there are 35 amendments to the UDC with the City Council and those same amendments will be heard by the Parish and decided on in January or February 2018. The Parish UDC is slightly different from the City of Shreveport UDC, but is effectively the same.

**Other Staff Reports** 

Mr. Sweeney announced that the MPC Holiday Luncheon is scheduled for Friday, December 8, 2017 at Wine Country Bistro on Line Avenue which will be for both Boards and the staff. Recognition certificates will be handed out at this luncheon for outstanding staff members and any recognition for Board members will also be at this time. Mr. Sweeney also reminded the Board of their requirement to complete the LA Ethics training by December 31, 2017. A training link has been emailed to all Board members. Mr. Sweeney announced that there is a possibility that there may not be a January ZBA meeting due to no cases being submitted. He will let the Board know definitively at the December 20, 2017 meeting.
