### **Master Plan Implementation Report**

- On February 28<sup>th</sup> the City Council adopted the UDC with the amendments we submitted. We anticipate a final vote by the Parish Commission on March 23<sup>rd</sup>. The effective date of the UDC implementation is May 15, 2017. Staff is currently in training on the UDC requirements & we hope to complete this training in April with the help of the
- consultants.
- We will schedule a series of outreach educational forums for the public.
- Mr. Sweeney explained the "overhang effect" during which the dates for the beginning of the UDC implementation overlap the current ordinance criteria. By August, all of our applications should fall completely under the UDC requirements.

### **BOARD MEMBER COMMENTS**

Mr. Sweeney reported that at the City Council meeting yesterday, 3 of our ZBA members were replaced. While we were aware & had notified the Mayor's Office that 2 of our members' terms had expired, we were completely unaware that the Mayor had submitted names of replacements for those members.

Members being replaced are: **JASON WALTMAN**, **BETTY OSBORN**, & **RICK HOLLAND**. They are being replaced by: Marshall Ferrell, Durwood Hendricks, & Cynthia Pearson. Apparently these replacements were discussed at a Department Head Staff Meeting - which is held each Monday morning in the Mayor's Office. Since Mr. Sweeney is not a City "Department Head", Mr. Sweeney does not attend every one of these meetings. No effort was made by the Mayor's staff to discuss this matter with us prior to the action taken at City Council yesterday. Chairman Berry & Board Members thanked Betty & Rick for all of their experience, knowledge, sense of civic responsibility & help they have given to fellow members over the years. What they contributed to this Board & to the citizens of Shreveport & Caddo Parish was invaluable.
